Biography of Helen B. Schleman

Helen Blanche Schleman (1902-1992), noted "unapologetic feminist," came to Purdue in 1934 as director of the first women's residence hall, subsequent to the razing of Ladies Hall in 1927. After taking a four-year leave of absence to serve in the Women's Coast Guard Reserve (SPARS) during World War II, Schleman returned to Purdue in 1947 as Dean of Women. She is acknowledged for having fought for women's rights at Purdue, including terminating the curfew for women students, spearheading a freshman conference program for women, and fighting for gender equity in the university's hiring and salary practices. While at Purdue, she earned a master's degree in education and psychology and she was also awarded honorary degrees from Purdue University and Valparaiso University. Schleman retired as Dean of Women in 1968 and went on to become founder and first director of the Span Plan, a program which encourages adult students to continue or start their college careers. She remained an active member of the community until her death in 1992. Schleman Hall, which now houses the Purdue's Student Services department, is named in her honor.

Materials within the collection

Collection Description

Scope

The Helen Schleman papers (1920–2001; 5 cubic feet) documents the life of Helen B. Schleman from her time as a student at Northwestern University in the 1920s to her death in 1992. Much of the collection documents Schleman's time at Purdue University as Head of Women's Residence Halls, Dean of Women, and Dean Emeritus, as well as her military service in the Coast Guard Women's Reserve (SPARs) during World War II. In addition to Purdue history, the collection contains Shleman's collection of newspaper clippings pertaining to the women's liberation struggle of the 1970s. Types of materials include personal and professional correspondence, school and employment records, speech notes, published material, newspaper clippings, photographs, pamphlets from professional organizations, and documents about Schleman's charitable work. The papers are organized into nine series:

Arrangement

1. Biographical information, 1921–2001 (0.6 cubic feet). This series contains Schleman's school, work, and military records; her curricula vitae; newspaper clippings about Schleman; an oral history interview; information about buildings, awards, and events named after Schleman; and will and testament documents.

2. Correspondence, 1943–1990 (0.2 cubic feet). Helen Schleman kept carbon copies of much of her outgoing correspondence. This series includes these carbon copies as well as the personal and professional correspondence that she received.

3. Speeches and written material 1923–1979 (0.5 cubic feet). This series contains various pamphlets and books authored by Schleman, copies of journal publications, and speech notes.

4. Personal files, 1950–1989 (0.5 cubic feet). Helen Schleman was meticulous about record keeping. This series contains files that she kept on friends or associates that were particularly important in her life. The files contain clippings, manuscripts, correspondence, and ephemera compiled by Schleman.

5. Pamphlets and publications, 1920–1988 (0.2 cubic feet). This series contains various pamphlets and publications, ranging from Schleman's time as an undergraduate at Northwestern University to a SPARs reunion pamphlet from 1988.

6. Other Purdue material, 1955–1985 (0.4 cubic feet). Of particular interest in this series are documents regarding Schleman's nomination of ten women for President of Purdue in 1970, the Schleman Gold Medallion Award, and the 1979 TIAA pension lawsuit claiming gender bias in university pensions.

7. Research Files, 1965–1992 (1.5 cubic feet). Helen Schleman kept files on many topics in the late 1960s and 1970s. Many of these files contain newspaper clippings about the ongoing women's liberation movement, particularly issues of women in the workplace. The clippings have been photocopied for preservation and transferred to archival folders, with the file name transcribed. This series is identical to Schleman's own filing system.

8. Photographs, circa 1920s–1992 (0.5 cubic feet). In addition to more official photographs such as professional portraits and Coast Guard photographs, this series contains hundreds of candid snapshots documenting Schleman's life, including her friendships with other Purdue Deans of Women.

9. Artifacts and Oversize Materials The original gold medallion presented to Schleman in 1968 and her military bracelet and insignia are particularly interesting items in this series. The oversized materials include periodicals and some large-format photos of Helen Schleman.

Processing Information

All materials have been housed in polyester sleeves, acid-free folders, and acid-free boxes. All newsprint has been photocopied and in most cases original newspaper clippings have been discarded. Some clippings containing images of people or color graphics, or front pages of newspapers, have been preserved for display purposes, with photocopies made available for research. Oversized periodicals [OVS], photographs, and artifacts have been separated and grouped into individual series for preservation purposes.

Some materials were damaged beyond repair by water and mold and had to be discarded. This included two folders of clippings and pamphlets about Schleman's retirement and the SPAN plan. Based on the remnants of these folders, most of this was duplicated material that did survive elsewhere, so there was little, if any, true loss. Also lost was a packet of information about artist Amy Freeman Lee, who was an "Old Master" at Purdue. This packet appears to have contained brochures and pamphlets about Amy Freeman Lee's art, but they did not appear unique or personal.

Additions

While processing the Dean of Women Office Records papers, the archivist discovered two cubic feet of speech notes, dated from 1944 to 1988, belonging to

Helen Schleman. This material has been organized by date into five manuscript boxes and added to Series 3 of the Helen Schleman papers.

In January 2013, Purdue's Women Studies program transferred approximately 18 cubic feet of historical documents to the Karnes Archives and Special Collections. Amongst this material was roughly two manuscript boxes worth of material collected by Helen Schleman that was determined to logically belong in MSF 334 Helen Schleman papers. These materials are housed in boxes 19 and 20, and each folder has been described below based on which series it intellectually resides within.

In June 2013, a file of Helen Schleman materials was found in the Mortar Board records and incorporated in MSF 334 as follows. Schleman's Coast Guard release documents were added to Box 1, Folder 3, and her Sigma Xi and Delta Kappa Gamma honor society certificates were added as Box 1, Folder 7. Several 3x5 color photographs of the Schleman Hall dedication ceremony were added to Series 8.
